My Google skills have become legendary and it has been a pleasure to pass on these bits of knowledge over the past few years. RIDERS UP!!!

How did the "Fastest Two Minutes in Sports" ever evolve? Naturally, I once again went to the "know it all" internet to find the answers to my curiosity.

The first Kentucky Derby was run in 1875; from the beginning it has been the first Saturday in May. There have been two exceptions – the first being WWII in 1945 and then due to Covid in 2020. Both races were rescheduled later that year.

However, this still did not answer my question as to how it all started. After digging deeper into the bowels of Wikipedia I finally hit pay dirt.

In 1872, Meriwether Lewis Clark, the grandson of explorer William Clark traveled to England and observed their Derby. While there he went on to watch The Grand Prix de Paris, the great horse race in France. Upon returning to Kentucky, he formed the Louisville Jockey Club. He was able to raise enough money to build a racetrack. Now he needed land on which to build it. Enter John and Henry Churchill. Clark was able to convince the Churchills horse racing would be a worthwhile investment. Thus, the Churchills gave him the land. For their land contribution it became forever known as The Churchill Downs where The Kentucky Derby is held.

The first race was held three years later in 1875. It was viewed by more than 10,000 screaming fans packed into Churchill Downs. As you are aware, every year it has grown in popularity. In 1925 a live radio broadcast was introduced. Then viewing the race on National TV was introduced in 1952.

Every year the crowds grew larger as did the winner's purse. The first one was \$100,000, but in 1996 the winning purse was one million dollars followed by two million, then three million and last year in 2024 it was FIVE MILLION.

The 2017 race took in a record \$209.2 million dollars from all wagering. Not only were there many unimaginable millions of dollars collected but there were 158,070 spectators sardined into Churchill Downs. I could not find an estimate of the number of people worldwide who watched the 2024 Kentucky Derby but given the international popularity of the race it was in the millions.

This year's field of horses are said to be some of the very fastest. Will they be able to break Secretariats' record of 1:59.4? This Saturday the tradition of the Mint Juleps and the elaborate ladies' hats will be everywhere.

You will hear the bugle blast the "Call to the Post." Then the University of Louisville will play "My Old Kentucky Home," and finally, "Riders Up." The horses are shoehorned at the starting gates, the bell rings, and they crash out of the gates.

The announcer calls out their names down the straightaway. He yells their names as they squeeze into the turns and by the fourth turn his voice is so hoarse he can hardly be understood. They are on the final straightway, their hoofs are pounding as hard as your heart, it is a blinding photo finish! You can hardly breath while you wait to hear the winner –

In 2019 Cadillac introduced the idea of EV concept cars, and originally the Lyriq was to be the show or concept car in 2020 but due to the pandemic it was delayed.



Now Cadillac has continued with their efforts to not only create new models, but redesign other models and introduce all electric versions of established vehicles such as the Escalade IQL, currently in production and available for purchase.

To keep with the tradition of the symbolism in the logo it is only natural to include this latest evolution in our club's repertoire.

I purchased a pair of these Fleetwood's a 1993 and a 1996 from my friends at Al's Auto Salvage in Franklin. The 1996 was a nice car and the 1993 was a parts car.

Once purchased, these beauties were delivered. We gave the 1996 a once over and my son took it for a test drive. As he was a block from the house the hood blew open and ripped off the car. It did not hit anyone or any vehicles on the road. It turns out the hood was not fastened at all other than the gas shocks. We took it home and installed the hood from the 1993 (same color).

When we started the 1993 and took it out for a test drive the exhaust broke off in the street and embedded itself in the asphalt suspending the car in the air.
